

ASIA PACIFIC ECONOMIES LEADING IN DIGITAL REVOLUTION

- 1) ASOCIO inaugural research reports highlights major initiatives in the creating a digital savvy population

TAIPEI, 11 October 2017 – The Asian-Oceanian Computing Industry Organization (ASOCIO) unveiled its inaugural research report today. Released on the side-lines of the joint session of the World Congress on IT (WCIT) 2017 and the ASOCIO Summit, the report outlines key policy recommendations for consideration in developing a digital agenda.

Speaking to journalist at the press conference, ASOCIO Chairman, David Wong expressed this confidence that the report will be a useful guide and barometer of the state of digital adoption in the region. He noted that while many economies in this region have a concerted focus on ICT and digital economies, there is still much work to be done.

“It is heartening to note that Asia Pacific is at the forefront of the digital revolution. Governments across the region have a serious and deep understanding of the impact technology has on the economy, population and social wellbeing,” highlighted David Wong.

The report covered titled “Reimagining the Digital Era - Digital Transformation Agendas & Initiatives Within the Asia Pacific Economies” covers 12 economies in the region across a broad spectrum of digital readiness and economic activity. In the report, it also highlighted areas of opportunities that economies in the region could avail itself in the digital future. This includes equipping the people with the necessary skills, ensuring equitable access and connectivity and embracing technology for the betterment of society.

Among the key recommendations of the report are:

- 1) Promote Fast and Ultra-Fast “Internet for All”
- 2) Build Robust Digital Ecosystem for Start-ups & SMEs

- 3) Address Needs of ICT Human Resources
- 4) Foster Cross-Border Investment and Digital Trade
- 5) Provide Impetus to Smart Cities Development
- 6) Ensure Faster Adoption of New & Emerging Technologies
- 7) Use ICT to Enhance Social Welfare
- 8) Address Regional Cyber Security Needs

The eight recommendations are supported by an enabling course of action to standardize measurement metrics on digital progress. This would provide a more accurate picture on the state of the digital readiness across the participating economies.

ASOCIO will be forming a Digital Advisory Council that will be made up of eminent figures in the digital forefront that will provide thought leadership and will help facilitate dialogues and discussions with governments and industries across.
